Sealed tenders in plain paper are invited from intending bidders for disposal of the following vehicles on as-is-where-is basis.

Tenders for each vehicle should be submitted separately super-scribing the vehicle **Registration Number** and the **Model** on top of the envelope. The sealed tenders should be submitted on or before **12.05.2015, 01:00PM** in the office of the Sr. GM (PS), OPTCL, SLDC, Mancheswar Rly. colony, Bhubaneswar-17, which shall be opened on **the same day at 3:30 P.M.** in the presence of the tenderers or their authorised representatives. The above mentioned vehicles can be inspected by the tenderers in the SLDC, premises during office hours.

The intending bidders are requested to pay **Rs.1,500/-** (Rupees one thousand five hundred) only for each vehicle as Earnest Money in shape of **Bank Draft** drawn in favour of **“Power Sytem, OPTCL, Bhubaneswar”**. The earnest money will be refunded to the unsuccessful tenderers. The highest tenderer will have to deposit 25% of the offered amount within five days with the D.D.O, (PS), SLDC, after the tender is accepted by the competent authority. The balance amount shall be deposited within ten days. If the tenderer fails to deposit the full amount within the stipulated period, the earnest money so deposited shall be forfeited.

The vehicle/ vehicles in case is/are not lifted within 30 days from the date of opening of tender/issuance of order, the ground rent, at the rate of 1% of the tendered amount for each day of delay will be charged. When the ground rent for each vehicle so charged exceeds the price deposited, the tenderer shall cease to have any right on the vehicle/ vehicles. The amount deposited by him shall be adjusted towards the ground rent and the vehicle / vehicles shall become the absolute property of OPTCL, free from encumbrance and to be disposed of by fresh tender.

The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
