**NOTIFICATION FOR FEES AND CHARGES FOR STATE  
LOAD DESPATCH CENTRE (SLDC) FOR THE FY 2023-24  
SLDC FEES & CHARGES WITH EFFECT FROM 01.04.2023**

The Odisha Electricity Regulatory Commission has passed an order on 23.03.2023 in Case No.77/2022 with regard to determination of fees & Charges for SLDC functions effective from 01.04.2023.

Pursuant to Regulation 57 of the OERC (Conduct of Business) Regulations, 2004 the SLDC hereby notifies the Schedule of Fees & Charges for its own functions.

**Schedule of Fees and Charges for SLDC functions**

1. The Fees & Charges for SLDC functions for the F.Y. 2023-24 shall be as under:

(A) Recovery of System Operation Charges (SOC) & Market Operation Charges (MOC) for SLDC Functions for the FY 2023-24 shall be as under:

SLDC shall raise bill and collect the SOC & MOC from Distribution Licensees, Buyers, Generating Companies (including CGPs) and sellers. SLDC shall also raise bill and collect SOC from Intra-State Transmission Licensee (OPTCL) who will use the services of SLDC.

(B) **Application Fee & Scheduling Charges:** SLDC shall collect the Application fee and Scheduling charges from the Open Access customers as per the provisions of OERC (Terms and Conditions of Intra-State Open Access) Regulations, 2020 for use of Intra-State Transmission System and its associated services.

(C) **Security Deposit:** The Customers other than Distribution Licensees shall pay an amount equivalent to two months' monthly SOC & MOC as the case may be in advance as security deposit against default in payment of SOC & MOC Charges of SLDC.

(D) **Registration Fee:** SLDC shall collect one time Registration Fee of Rs.1.00 Lakh per user for use of Intra-State Transmission System and its associated services.

(E) **Late Payment Surcharge:** In case of payment of bills by any user is made beyond a period of 60 days from the date of billing, a late payment surcharge at the rate of 1.25% per month shall be levied by SLDC on the amount remaining unpaid.

2. The Fees & Charges for SLDC functions as mentioned in Para-1 above shall be effective from 01.04.2023 and shall continue till further order of the Commission.
